Dear AS&T Members,

Our 2018 season begins on Saturday, May 26th and the registration packets for membership is enclosed. To join, please complete the Membership Agreement form and enclose any activity registration forms, medical releases, and code of conduct forms along with a check for the correct amount from the payment summary page which reflects your Annual Maintenance and total activity fees outlined in this letter. If you'd like to sign up for the swim, dive and tennis teams, please fill out the applicable registration forms.

In your package, there is a Summary Payment page. Please use this so that we can make sure we credit your payments correctly. Some folks sign up for many things (membership, visitor passes, swim team, dive team, etc...) and just write one check. That is ok, but if you can help us out by filling out the Summary Payment sheet, that would make our job a little easier.

We are continuing selling visitor passes like last year. If you buy a visitor pass between now and 10 Jun, the visitor pass will only be \$40. After 10 Jun, the price goes up to \$50. If you order your pass before the pool opens, we will have them at the front desk in an envelope for you. Just add the amount to the Summary Payment page and add the amount to the check you send. Visitor passes expire after Labor Day 2018.

Annandale Swim and Tennis Club 2018 Fee Structure

All AS&T members must pay an annual maintenance fee. 2018 annual maintenance fees are:

	Maintenance Fee
Single	\$370
2 People	\$500
3 People	\$500
4 People	\$500
5 + People	\$500
Senior Person*	\$400
Senior Couple*	\$400
AS&T Board Members	\$300

*Senior Citizens must be at least 62 years of age

There is a \$50 discount on the maintenance fee if paid by 1 May.

The maintenance fee covers the use of all AS&T facilities from May 1, 2018, to April 30, 2019.

The annual maintenance fee must be paid for all family members, even if one or more of those family members does not intend to use the swimming pool, except:

- a. Children under the age of one year on June 1, 2018;
- b. Persons who for medical or other reasons (such as being gone for the entire summer) cannot enjoy the facilities; &
- c. AS&T employees.

AS&T members (and all of their family members) who have not paid their annual maintenance fee may not use AS&T facilities, including the tennis courts, even as a guest of another member. This prohibition does not apply to new members, however, because the annual maintenance fee is waived during the first year of membership.

Whenever AS&T facilities are closed (including September-May), the tennis courts will be locked. To use the tennis courts during such times, AS&T members may obtain a tennis court key at the front desk (\$20 deposit required), but this key may not be loaned out or duplicated. There may be occasions when the tennis courts cannot be used because of other scheduled activities, but advance notice of such activities will be provided whenever possible.

2018 Annual Membership Agreement

1. I hereby enclose \$ _____ as my annual maintenance fees for the 2018 summer season. I understand that the payment of this fee entitles me and members of my family, listed and described on the reverse side, to admission to AS&T facilities during the hours that the pool is open for normal operations, provided we abide by the rules and regulations. Also, I understand that I am responsible for complying with the AS&T guest policy and those violators of this policy are subject to suspension from AS&T facilities and activities.

2. I hereby waive all rights, claims, causes of action and rights of action against the AS&T Directors and Officers for any property damage or personal injury arising from the use of the facility by any members of my family or our guests. I agree that AS&T and its Directors and Officers shall not be liable for any loss, injury or damage which may occur during the use of the facility, unless caused by the negligence of AS&T or its employees.

3. It is understood and agreed by the undersigned that all AS&T rules and regulations are a part of this agreement. Members agree to comply at all times with such rules and regulations. It is further understood and agreed that no person may use the AS&T facilities until all required fees or installment payments have been paid and a copy of this agreement has been signed. No alteration of this agreement or any other membership document will be effective without the express concurrence of the Board of Directors.
